I, the undersigned, am the owner or manager of certain real property located at the above listed service address. As such, I hereby confirm that I have the authority to sign this Letter of Authorization. I understand that service to the above-mentioned premises shall be in the name of the tenant and:

1. **for power**, I agree, per the State of Tennessee Uniform Residential Landlord and Tenant Act, that a) I cannot terminate or interrupt utility service to the premises, b) that only the tenant/Meriwether Lewis account holder can terminate or interrupt the service, c) that tenants are entitled to occupy the premises known by the Cooperative as the MLEC Meter Number.
2. **for broadband**, I agree that a) a fiber drop to the building/structure is required, b) Meriwether Lewis is allowed to access the property at its discretion to complete the drop construction, c) that the inside installation and service activation will be scheduled with the tenant, and an adult must be present for this step, and d) proper installation will likely require drilling small access holes through interior and/or exterior walls for fiber cabling and equipment installation. (Please note: Availability of MLConnect service to multi-dwelling units is dependent on current serviceability and may vary by location.)
3. **for either power or broadband**, I authorize Meriwether Lewis and its agents to have reasonable access to the property/premises at any time to make modifications as needed for the purpose of maintaining or improving the service(s) provided. Meriwether Lewis is not responsible for the removal of any hardware located on/in the home or business, nor is Meriwether Lewis responsible for restoring the property to its original condition upon termination of the account.
